2) Review of Minutes

4) Office of Research Services and Sponsored Projects, ORSSP

- a) Establishing the ORSSP comes from the Faculty Development element within the Academic Strategic Action Plan to enhance research infrastructure.
- b) This office will consist of:
 - i) One internal half-time position, held by a faculty member
 - (1) To serve as a promoter for faculty research, a "cheerleader"
 - (2) Will report to Jacquelyn Miller.
 - ii) One staff position, "Grants and Contracts Financial Analyst", which is currently up on the HR job site.
 - iii) Leesa Brown, Sponsored Research Officer (will report to the internal half-time position)
- c) The ORSSP will be located in the University Services Building, in the old controller's office.

5) ASSU Sustainability, McKenzie Weber & Merlin Goodman

- a) Merlin Goodman joined Academic Assembly with a presentation on sustainability.
- b) Students are concerned with paper use on campus, and looking at coming up with an idea that both faculty and students can work with.
- c) The goal is to reduce paper use on campus through technology, the use of an Angel drop-box.
- d) Continuing the commitment to sustainability.

6) EthicsPoint

- a) E-mail to campus community Wednesday October 28th from the President.
- b) EthicsPoint is an anonymous reporting site for ethics violations. An effort to become in line with other Jesuit universities in the ethics reporting structure.
- c) EthicsPoint allows a member of the faculty/staff to make a report without divulging their identity.
- d) There are questions that still need to be answered:
 - i) What are the policies and procedure of the structure of this reporting site?
 - ii) How does this mesh with the existing structures?

Action Item: Academic Assembly will invite legal counsel to a meeting later in the quarter.

7) Oversight of Curricular Matters

- a) As SU expands, how far does the Assembly want to go? What do we want oversight of?
- b) Program Review Committee, only to review new degree programs? Expansion into minors & certificates, revision of majors?
 - i) Currently in the revision process of the Program Review Guidelines. Goal for departments to put forth comprehensive proposals, pushing the development requirements, and to provide sufficient data when proposing a new degree.
 - ii) Process of review: Program Review Committee → Academic Assembly → Provost → Board of Trustees. Along the way there are meetings with the Dean of the School/College and Chairs of the department for discussion.
- c) Curricula is the province of the faculty.
- d) What are best practices at peer institutions.
